

FORM OF TENDER AND AGREEMENT

INSTRUCTIONS TO TENDERERS

LEIBNER DRAIN

Municipality of West Elgin

1. Sealed tenders shall be received at the Municipal Offices on 12:00 Noon Thurs May 2 / 2019
at 22413 Hoskins Line, Box 490, Rodney, Ontario N0L 2C0
2. **SPECIFICATIONS:** The drain shall be constructed in accordance with the Contract Drawings and Specifications for Construction of Municipal Drainage Works, dated January, 2009, consisting of the following:
 - Contract Drawings
 - General Conditions
 - Open Drain
 - Tile Drain
 - Specifications for Municipal Drains Crossing County Roads
 - Standard Drawings
3. **TENDERER TO INVESTIGATE:** The Tenderer shall examine the premises and site to compare them with the drawings and specifications in order to satisfy himself of the existing conditions and the extent of the work to be done before submission of his tender. No allowance shall subsequently be made on behalf of the Contractor by reason of any error on his part. If required, the above specifications and/or further information are available at the office of the Engineers, Spriet Associates London Limited, 155 York Street, London, Ontario N6A 1A8.

Any estimates of quantities shown or indicated on the drawings or extent of work or in the report of "neat" calculations and are provided for the convenience of the Tenderer. Any use made of these quantities by the Tenderer in calculating his tender shall be done at his own risk. The Tenderer, for his own protection, should check these quantities for accuracy.
4. **PRICES SUBMITTED:** The tender price or prices tendered in the Tender shall be in full compensation for all labour, equipment and materials and utility and transportation services necessary to perform and complete all work under the Contract, including all miscellaneous work, whether specifically included in the Tender Documents or not. It is the intention of the Drawings and Specifications to provide finished work. Any items omitted therefrom which are clearly necessary for the completion of the work shall be considered part of the work, though not directly specified in the Tender Documents.
5. **ACCEPTANCE:** Tenders shall be made on a lump sum basis on the forms provided. It shall be noted that any alteration of the "Form of Tender and Agreement", failure to complete the Form of Tender in full or any other requirements set out in these documents, will render the tender liable to rejection by the Municipality. Acceptance of the Tender by the Municipality shall constitute a formal and binding contract when signed by the Municipal Officials.

The Tenderer shall keep his Tender open for acceptance and irrevocable until 45 days have elapsed from the closing date of the Tender or a formal contract is executed, based on a Tender other than his own.
6. **TENDER SECURITY:** A bid deposit is required as tender security and shall equal the sum of 10% of the value included in the tender price including H.S.T. The bid deposit shall be in the form of a certified cheque payable to the Municipality. The cheque deposited by the unsuccessful Tenderers will be returned without delay.
7. **CONTRACT SECURITY:** The bid deposit of the successful Tender shall be retained by the Municipality until the contract is completed and a completion certificate is issued by the Engineer. The successful Contractor shall have the option of furnishing the Municipality with a Performance Bond to replace the bid deposit as outlined. The Performance Bond shall ensure completion of the work and maintenance of the work for a period of one year after the date of the completion certificate.
8. **TAXES:** The total contract price shall be inclusive of all applicable taxes, including Harmonized Sales Tax (H.S.T.), custom duties and excise taxes applicable with respect to the contract, and shall be paid by the Contractor unless otherwise provided by statute. The estimated amount of H.S.T. must be disclosed separately on the Form of Tender. The Municipality will pay the Contractor all amounts of the H.S.T. in respect of the project.
9. **INSURANCE:** The successful Contractor shall be required to provide insurance in accordance with Section A.12 of the General Conditions, Insurance, and within 7 days of the award of the contract and prior to commencing work
10. **CERTIFICATE OF CLEARANCE:** The successful Contractor shall provide a Certificate of Clearance from the Workplace Safety and Insurance Board within 7 days of the award of the contract and prior to commencing work, stating that all compensation has been paid.

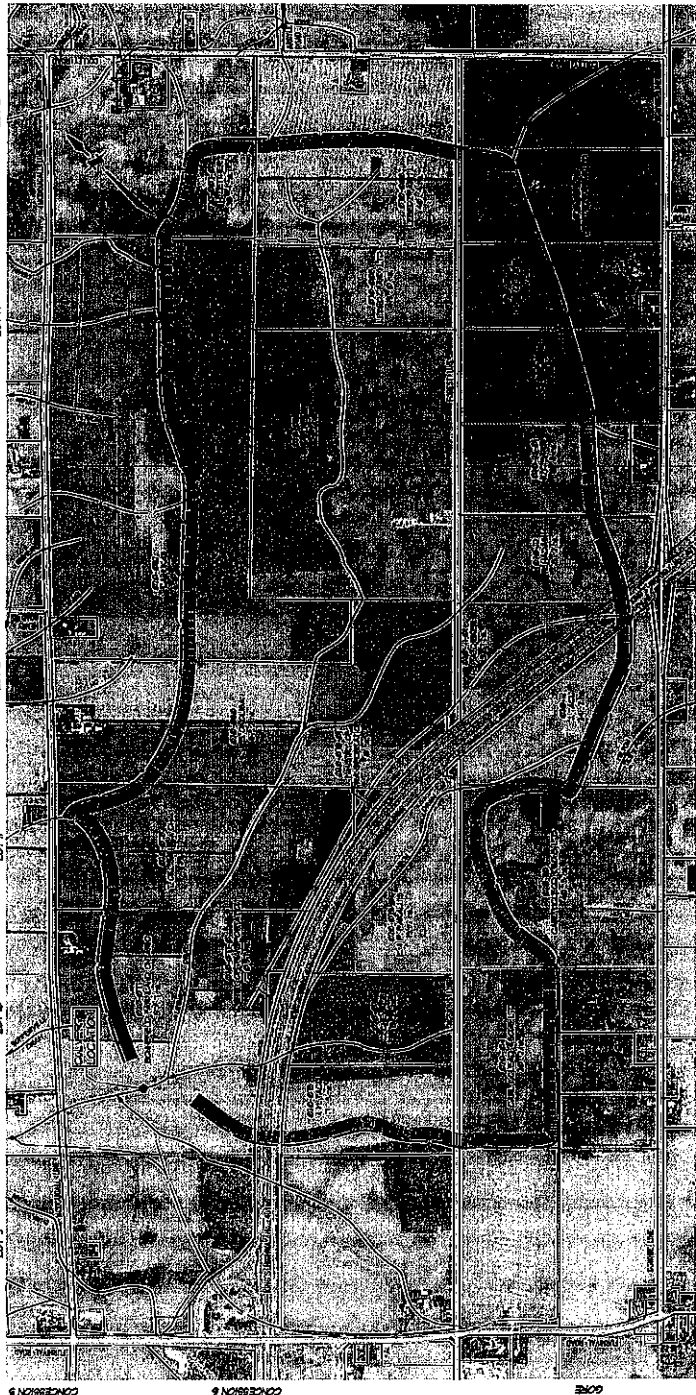

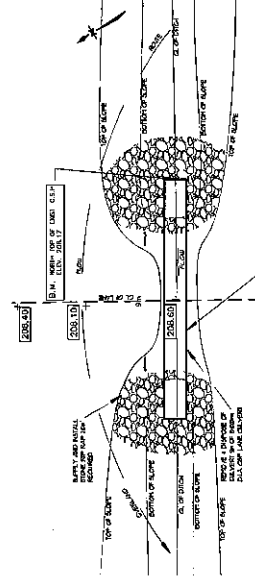

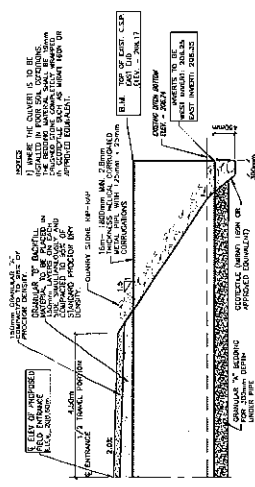
