## **The Corporation Of The Municipality Of West Elgin**

### **By-Law No. 2019-101**

#### **Being a By-Law to Establish Rates for Municipal Water and Wastewater Services for 2019.**

**Whereas** Section 5(3) of the *Municipal Act, 2001, S.O. 2001, c.25*, as amended, provides that a municipal power shall be exercised by by-law; and

**Whereas** Section 10(1) of the *Municipal Act*, provides that a municipality may provide any service or thing that municipality considers necessary or desirable for the public; and

**Whereas** Section 10(2) of the *Municipal Act*, provides that a municipality may pass by-laws respecting: in paragraph 7, Services and things that the municipality is authorized to provide under subsection (1); and

**Whereas** Section 391(1) of the *Municipal Act*, provides that a municipality may impose fees or charges on persons:

- (a) for services and activities provided or done by or on behalf of it;
  - (b) for costs payable by it for services and activities provided or done by or on behalf of any other municipality or any local board; and
- for the use of its property including property under its control; and

**Whereas** the Council of the Municipality of West Elgin approved recommendations in the Municipality of West Elgin Drinking Water System Rate Report prepared by Sharratt Water Management Ltd on May 6, 2019 and the West Elgin Wastewater System Rate Report prepared by Sharratt Water Management Ltd on July 15, 2019, that is consistent with the requirements of the *Sustainable Water and Sewer Systems Act, 2002* as amended as well as the *Safe Drinking Water Act, 2002* as amended and associated *Ontario Regulation 453/07*;

**Now therefore** the Council of the Municipality of West Elgin enacts as follows:

1. That the Water Rates and Charges for the West Elgin Water System as shown on attached Schedule 'A' are approved.

2. That the Sewage Rates for West Lorne as shown on attached Schedule 'B' are approved.
3. That the Sewage Rates for Rodney as shown on attached Schedule 'C' are approved.
4. The rates set out on attached schedules come into force and effect on the dates stated in the schedules.

Read a first, second, and third time and finally passed this 19<sup>th</sup> day of December 2019.

Effective July 1, 2019

Flat Rate (bi-monthly service charge)	\$38.11
Consumption Rate	\$1.45 per m <sup>3</sup>
Water Station Rate	\$2.90 per m <sup>3</sup>

### West Lorne Sewage Rates

Effective July 1, 2019

Residential Flat Rate	\$55.64
Sewer Consumption Rate	\$2.12 per m <sup>3</sup>

### Rodney Sewage Rates

Effective July 1, 2019

Residential Flat Rate	\$58.31
Sewer Consumption Rate	\$2.22 per m <sup>3</sup>
